The Asiatic Society, Kolkata invites sealed tenders under Two Bid System from reputed, Government enlisted, experienced and financially resourceful contractors for **Providing and fixing up Gypsum board partition, ply board partition and painting works** in the Salt Lake Building of the Asiatic Society, Sector – II, Salt Lake.

#### Scope of Work & General Instruction for Tenderers

1. <u>Scope of the Work</u>: Providing and fixing up Gypsum board partition, ply board partition and painting works in the Salt Lake Building of the Asiatic Society, Sector – II, Salt Lake.

#### 2. Eligibility Criteria for participation in the Tendering process:

- a) The Contractor should have experience of carrying out similar works with the Departments of the Government of India/Statutory Bodies/Central Autonomous Bodies/PSUs/ Reputed Private Sectors during last **Five** years.
- b) The average annual turnover of the Contractor during the last 3 financial years should not be less than **Rupees Five Lakh** only from similar works. The contractor should also have earned profit during the last three years.
- c) The contractor should have valid enlistment with any Departments of the Government of India/Statutory Bodies/Central Autonomous Bodies/PSUs.
- d) The contractor should be registered with Income Tax and Goods and Service Tax authorities.
- e) The Contractor should have an office in Kolkata / Kolkata UA.
- f) The Contractor shall submit an affidavit stating that it is not / has not been black listed by Central/State Government/ any PSUs/Private Sector at any point of time.

Non-compliance with any of the conditions mentioned in 2 above by the Contractor will amount to noneligibility for the work for which tender has been floated and its tender will be summarily rejected.

#### 3. Submission of Bid:

- a) The bid shall consist of two parts: Technical Bid and Price Bid. Both the bids are to be placed in two separate sealed envelopes (clearly superscribing 'Technical Bid' and 'Price Bid') which in turn are to be placed in a sealed cover. The bids of all the tenderers whose Price Bid is not in a separate sealed envelope shall be rejected forthwith. The Price bids of only those tenderers shall be opened whose Technical bids are found to be eligible while the disqualified bidders' Price Bid shall be returned unopened.
- b) The bid document shall be clearly and legibly written and each page must be signed by the authorized signatory of the bidder and seal affixed. Erasing or over writing in the bid document shall not be allowed. Corrections in the bid document should be avoided but if this becomes unavoidable, each correction should be signed separately and without ambiguity.

## 4. Earnest Money Deposit:

- a) The Technical Bid should be accompanied with an Earnest Money Deposit (EMD) of Rs 3,500/-[Rupees three thousand five hundred] only in the form of Demand Draft drawn in favour of The Asiatic Society, payable at Kolkata failing which the tender shall be rejected out rightly. EMD exemption of any category will not be accepted.
- b) The EMD of all unsuccessful bidders shall be returned to them without any interest after awarding the work to the successful bidder and entering into the contract.
- 5. The intending tenderers may visit and inspect the site of work and make necessary investigation in regard to communication facilities, source of water supply and power and other important points before submission of tenders within the date and time specified.
- 6. The bid should be valid for a minimum period of thirty days from the date of the opening of bids.

#### **General Terms and Conditions**

- 1. Successful bidder [Contractor] shall execute an agreement for the fulfillment of the contract on a Non Judicial stamp paper of ` 100/- within seven (7) days from the date of issue of the work order and only after the submission of the Performance Security as specified in Clause 4 below.
- 2. The period of contract for completion of the work shall be 15 (fifteen) working days from the date of issue of the Work Order.
- 3. The standard terms of payment are within 30 days from the date of submission of bills in triplicate along with satisfactory work completion certificate issued by the Maintenance Section of The Asiatic Society. The payment shall be made through RTGS/NEFT. The Income Tax and other statutory deductions, as applicable will be deducted from the payment.
- 4. Successful bidder [Contractor] shall have to furnish Security Deposit (interest free) @ 5% of the quoted price. For this, the earnest money will automatically be converted as part of security deposit. Balance amount of Security Deposit will be paid in the form of Demand Draft/ Bank Guarantee in favour of the Asiatic Society, Kolkata. The Security Deposit will be retained by the Society for a period of 180 days beyond the contract period. No interest will be payable on the Security Deposit.
- 5. If the contractor fails to provide satisfactory performance during the contract period, the Security deposit furnished by it will be forfeited without prejudice to other remedies.
- 6. If the contractor fails to complete the work with the stipulated time period, liquidated damage @ 0.5% of the total value of work per day and part thereof subject to a maximum 5% of the total value of the contract will be deducted from the final value of the bill.
- 7. The contractor, will carry necessary tools, materials etc at his own cost. The contractor will borne the expenses towards transport, erection and maintenance of plant, all running expenses including fuel or power and ultimate removal of the plant and equipment and storage of materials and removal of rubbish and all other charges.
- 8. The contractor will provide to the Asiatic Society, Kolkata a list of all personnel so engaged for the purpose with permanent and present address along with their latest photographs.

- 9. The contractor shall be responsible for all acts of commission and omission on the part of the personnel engaged for the purpose. The Asiatic Society, Kolkata shall not be responsible in any manner, whatsoever, in matters of injury/death/health etc. of the contractor's employees performing duties under the contract.
- 10. The contractor shall be responsible for any damages done to the property of the Society by the personnel so engaged. The Asiatic Society, Kolkata will be free to recover it from the security deposit given by the contractor or from any other dues.
- 11. The contractor shall be responsible for compliance of all statutory provisions relating to Minimum wages, Provident Fund, Workmen's Compensation, and Employees State Insurance etc. if applicable in respect of the persons engaged by it in the Asiatic Society, Kolkata for the purpose.
- 12. Any dispute/difference arising out of or relating to this agreement including interpretation of its terms will be resolved through joint discussions of the concerned parties. However, if disputes are not resolved by joint discussions, then the matter will be referred to arbitration as per the provisions of Arbitration Act, 1940, where the General Secretary, The Asiatic Society, Kolkata or his nominee will be the Sole Arbitrator.
- 13. The Asiatic Society, Kolkata reserves the right to terminate the contract at any point of time after giving a week's notice to the contractor without assigning any reason, if the work of the contractor is found unsatisfactory. The Asiatic Society, Kolkata may also resort to blacklist the contractor for a suitable time period on the lapse on its part.
- 14. All disputes are subject to the jurisdiction of Courts in Kolkata.
